## Rules & Information

- ⚓ Upon arrival, all boaters must check-in and pay docking fees. **NOTE THERE IS NO FREE 2-HOUR TRANSIENT PARKING.**
- ⚓ Stays are limited to five nights in, seven nights out. Other stays are based on proportionate days (1 in 2 out, etc.)
- ⚓ Park is open May 1-October 30
- ⚓ Quiet hours are 11:00pm-6:00am as per city ordinance.
- ⚓ Boaters must pay daily. If planning a multiple night stay, the boaters can pay the lump sum upfront but will not be permitted to pay at the end of a stay.
- ⚓ **Any boater who has docked for any period and hasn't submitted payment will be subject to a parking citation from the NTPD in addition to paying the daily/overnight fees owed. Failure to pay fees owed will result in the boat being towed at the owner's expense.**

### \*Transient 2hr Docking Fee:

All boat sizes:           \$5

\*For boats docking for any period under 2 hours. Fee must be paid at the time of arrival or your boat will be subject to a parking citation. Boats that pay, but stay longer than 2 hours will be charged the daily fee rate.

### Daily Fees: (leave the harbor by 10pm)

25' & Under	\$15
26'to 40'	\$20
41' & Over	\$25
Commercial Boats	\$35

### Overnight Fees with Electric & Water: (any stay after 10pm; check out 11am next day)

25' & Under	\$30
26' to 40'	\$35
41' & Over	\$40
Commercial Boats	\$50

### Overnight Fees Without Electric & Water: (any stay after 10pm; check out 11am next day)

25' & Under	\$25
26' to 40'	\$30
41' & Over	\$35

## Rules & Information (continued)

- ⓧ The City is not responsible for security of any boat or personal possessions.
- ⓧ Any dogs or pets must be leashed and under owners' control. Pets must be kept on boats during concerts and special events.
- ⓧ Glass containers are prohibited
- ⓧ Garbage must be properly disposed of in receptacles. There is to be no repair of boats or discarding of construction materials in the park.
- ⓧ Disorderly conduct or excessive noise are prohibited, and are grounds of removal from the park/docking area.
- ⓧ Firearms and fireworks are prohibited.
- ⓧ All walkways and seating areas must be kept clear and open for the public. Tents, grills, and personal items cannot be set up in the public dock seating areas.
- ⓧ Fueling of boats is not permitted in the park.
- ⓧ No dumping or pump outs permitted.
